Criteria for selection of Enumerators for the 2021 Livestock Census of Bhutan

General Selection criteria:

1. University Graduate (in any field) currently residing in the Dzongkhag
2. Good command over the local dialect to effectively communicate with respondents
3. Should be healthy and comfortable in travelling
4. Should have android cellphones to facilitate CAPI data collection
5. Degree Marks (in any field) – 95 %; and
6. Experience Certificate for enumeration (if any) – 5%

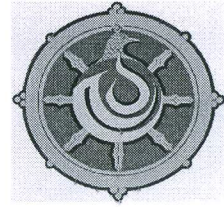
Terms of Reference:

1. The selected candidates shall be hired as Enumerators for the tentative period one month (15th November to 15th December 2021)
2. The Enumerators shall undergo training at Dzongkhag Conference Hall for 3 days (1-3 November, 2021)
3. The Enumerators shall co-ordinate and co-operate with Supervisor (**Dzongkhag Livestock Officer**) to plan and conduct Livestock Census in the Dzongkhag.
4. The Enumerators shall assist Supervisor to update work progress and support the supervisor wherever necessary; and
5. Both Supervisor and Enumerators should follow strict Covid-19 protocols.

Remuneration/Benefits:

1. The Enumerators shall be paid **Nu.1, 100** per day during the field enumeration.
2. The Enumerators shall be paid **Nu.400** per day and working lunch/tea/snacks during the 3 days training period.
3. A nominal talk time voucher allowances of **Nu. 1,000** shall be paid for the whole duration.
4. The **free transportation** shall be provided.
5. Upon successful completion of the task the Dzongkhag Administration may consider issuing **Certificate of Appreciation**.
